1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to 1832 AM Fundamental Canadian Equity Pool.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 — Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with IFRS Accounting Standards.

Investment Objective and Strategies

The Fund's investment objective is to achieve long-term capital growth by investing in a diversified portfolio of equity securities primarily issued by Canadian companies.

The Fund seeks to achieve its investment objective by investing primarily in large cap stocks issued by Canadian companies with high growth potential.

The portfolio adviser uses a fundamental investment approach that focuses on high quality businesses with attractive earnings prospects at reasonable valuations. Based on the fundamental analysis, the portfolio adviser identifies investment opportunities that are industry leaders with unrecognized growth potential.

As part of the fundamental research, the portfolio adviser conducts detailed and rigorous analysis on:

- management teams and corporate governance structure
- historical earnings track record
- financial leverage
- · valuation levels and,
- future growth potential

The Fund can invest up to 49% of its total assets in foreign securities.

Risk

The risks associated with investing in the Fund are as described in the simplified prospectus. There were no material changes to the Fund over its last completed financial year that affected the overall level of risk of the Fund.

Results of Operations

For the year ended at December 31, 2023 (the "period"), the Series I units of the Fund generated a total return of 20.4%. Fund returns are reported net of all management fees and expenses, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses.

The Fund's broad-based benchmark, the S&P/TSX Composite Index returned 11.8% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund's performance relative to the general performance of the market.

For the full calendar year, the portfolio posted very strong returns and substantially outperformed the index. The main contributors to our outperformance were the overweight position in Industrials (+11.9%) and Information Technology (+68.3%) and underweight in Communication Services (-3.8%), which was partly offset by lower portfolio returns in Consumer Staples (+12.2%). We remained underweight in Energy (+6.3%) and Materials (-1.2%), which was a net benefit as both sectors underperformed the index.

Our notable overweight position in Engineering Services was an important relative contributor for the year, led by AtkinsRéalis (+79%) and Stantec (+65%).

AtkinsRéalis produced industry-leading double-digit organic growth from Engineering Services and the orderly winddown of the problematic lump sum business is progressing as planned. As a result, the market is beginning to recognize the quality of the remaining businesses. Despite the strong stock recovery, the stock remains attractively valued.

Similarly, Stantec continues to benefit from strong industry fundamentals, posting nearly 11% organic growth in 2023 and introducing a new multi-year plan in December, which calls for 14% revenue growth and mid to high teens earnings per share growth over the next three years.

Open Text (+42%) was also a significant contributor due to strong EBITDA growth of 58% driven by the Micro Focus acquisition and late in the last quarter, the well-received \$2.275b divestiture of the legacy mainframe business to Rocket Software.

These were partly offset by the relative underperformance of Franco Nevada (-20%), Altus Group (-21%) and METRO (-7%). Franco Nevada underperformed due to the forced shutdown of its largest royalty asset, as noted above.

Altus, a leading Commercial Real Estate (CRE) valuation software and services provider, continues to see slower new business bookings due to depressed CRE transaction activity. Despite the challenging environment, the company's results were resilient and management took advantage of the circumstances

with the proposed acquisition of REVS, a highly regarded competitor in valuation management services.

METRO introduced one-time guidance for 2024 when expectations failed to incorporate the significant costs of warehouse duplication as they transition to new, highly automated distribution centers. Additionally, sentiment has deteriorated somewhat due to ongoing and misplaced political pressure on the grocers to lower prices. Despite these headwinds, the long-term earnings outlook for 8–10% compound annual growth remains intact; however, the growth cadence has changed with lower or negative returns in 2024, followed by higher expected growth in 2025 and beyond.

During the period, top individual contributors to performance included Shopify, SNC Group and Stantec. Top individual detractors from performance included Franco Nev Corp, Altus Group and Saputo.

We opportunistically initiated a position in Tourmaline. Due to the warm winter, storage filled quickly in natural gas and pushed commodity prices to near-decade lows and at approximately half of our medium-term expectation based on increasing export capacity to help rebalance the global LNG markets post-Russia's invasion of Ukraine. We believe that natural gas will play an important role as a transition fuel. We expect Tourmaline to benefit as North American LNG export capacity doubles by the end of the decade.

We added to Open Text and TC Energy. We funded these additions by trimming Saputo, Stantec and WSP. Saputo performed well in 2022, but much of the improvement in earnings is reflected in the valuation. We reduced our positions in Stantec and WSP due to significant outperformance over the long term, resulting in relatively large positions in the portfolio.

We continued to build our TC Energy position on weakness, benefiting from a 7% yield while we waited for the sale of assets to materialize, which we believe would be a catalyst for the stock. We also added to our position in Brookfield Corporation on the basis that its substantial discount to Net Asset Value more than reflects any weakness in commercial real estate or private equity that we see on the horizon. Lastly, we added to Colliers, a company with excellent management and solid historical shareholder value creation that is cyclically under pressure due to current Real Estate industry concerns.

We trimmed three technology-related companies, Shopify, Thomson Reuters and CGI, as improved valuations have resulted in lowered expected returns.

We also folded our position in Brookfield Asset Management into its parent company, Brookfield Corporation, following the spin-off late last year.

The Fund's net asset value decreased to \$580.3 million at December 31, 2023, from \$582.5 million at December 31, 2022. This change was composed of net redemptions of \$112.7 million, cash distributions of \$24 and investment performance of \$110.5 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year

mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

The Fund may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions exceeds the portion of net income and net realized capital gains, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

There have been no recent developments that have affected, or are likely to materially affect the Fund.

Related Party Transactions

The Manager is a wholly owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

Related Brokerage Commissions

From time to time, the Fund may enter into portfolio securities transactions with Scotia Capital Inc. or other related dealers in whom Scotiabank has a significant interest (a "Related Broker").

These Related Brokers may earn commission or spreads on such transactions, which are made on terms and conditions that are comparable to transactions made with non-related brokers.

During the period, the Fund paid \$4,306 in commissions to Related Brokers.

Related Sub-Advisor

The Fund is sub-advised by Jarislowsky Fraser Limited, a related party to the fund. The Manager may pay a fee, which is negotiated with the sub-advisor, to the sub-advisor in respect of the investment advisory services provided to the Fund.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 — Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has four members, Stephen J. Griggs (Chair), Steven Donald, Heather A. T. Hunter and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives

an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are allocated among all of the funds managed by the Manager for which the IRC acts as the independent review committee in a manner that is considered by the Manager to be fair and reasonable. The main component of compensation is an annual retainer fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;

- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, relied on IRC standing instructions regarding related party transactions during the period.

Management Fees


The Manager is not entitled to a management fee payable by the Fund in respect of Series I units. The management fee is negotiable and paid by unitholders directly to the Manager.
