1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to 1832 AM International Growth Equity Pool.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with IFRS Accounting Standards.

Investment Objective and Strategies

The Fund's investment objective is to achieve long-term capital growth by investing primarily in equity securities in developed markets outside of Canada and the U.S. and in developing markets.

The Fund seeks to achieve its investment objective by investing in a diversified portfolio of publicly traded equity securities of companies located outside of North America.

The portfolio adviser employs an active, fundamental, bottom-up, growth-oriented investment discipline to identify growing companies and companies undergoing significant change, allowing the Fund to capitalize on such developments.

The portfolio adviser conducts detailed fundamental stock analysis to identify companies whose current operational metrics are materially pacing ahead of market expectations, where these operational improvements are not yet reflected by the market and where these improvements will lead to earnings upgrades and share price appreciation.

The Fund can invest up to 100% of its assets in foreign securities.

Risk

The risks associated with investing in the Fund are as described in the simplified prospectus. There were no material changes to the Fund over its last completed financial year that affected the overall level of risk of the Fund.

Results of Operations

For the year ended at December 31, 2023 (the "period"), the Series I units of the Fund generated a total return of 17.4%. Fund returns are reported net of all management fees and expenses, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses.

The Fund's broad-based benchmark, the MSCI ACWI ex. U.S. (C\$) returned 13.6% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund's performance relative to the general performance of the market.

During the period, inflation continued to moderate globally, nearly recovering to pre-pandemic levels after steadily improving for about 18 months. The global easing cycle came into evidence beginning in mid-2023, with 48 interest rate reductions between July and year-end, exceeding the 43 rate increases during the same period. The cycle of interest rate reductions was led by emerging markets, just as the cycle of increases had previously been. Federal funds futures suggested between five and six reductions in the U.S. Federal Reserve Board's federal funds rate during 2024, with the first reduction anticipated by late spring.

Global economic growth showed signs of stabilizing at period-end, after having dipped sharply in the middle of 2023. Market valuations were attractive, with global, international and emerging markets indices all trading at price/earnings-to-growth ratios well below their seven- and 10-year averages. However, equity markets continued to face several challenges at the end of the period. Geopolitical instability, still-accelerating fiscal deficits, deglobalization and demographic challenges all remained substantial risks.

The Fund outperformed the broad-based benchmark as a result of stock selection in the Information Technology and Health Care sectors, as well as in the U.S., Denmark and China.

The Fund's overweight exposure to the Information Technology sector also contributed to performance. Top individual contributors to performance included NVIDIA Corp., Novo Nordisk AS and MercadoLibre Inc. NVIDIA benefited from robust earnings results that surpassed investor expectations. Tracking of quarterly wafer procurement plans also pointed to the potential for continued growth over the medium term. Novo Nordisk performed well given the ongoing ramp-up of glucagon-like peptide 1 ("GLP-1") capacity, which is expected to continue throughout 2024. Prices for GLP-1 scripts continue to rebound from second-quarter 2023 lows. Additional label use for conditions such as obesity and cardiovascular disease could also support incremental sales. MercadoLibre consistently exceeded market expectations with respect to both revenue growth and profitability. Alongside positive company-specific factors (e.g., robust logistics capabilities, product assortment), MercadoLibre's competitive environment has also improved.

Stock selection in the Industrials and Financials sectors detracted from performance, as did stock selection in Japan, Germany and Canada. Adyen NV, Alibaba Group Holding Ltd. and Rentokil Initial PLC were among the top individual detractors from performance. Adyen missed consensus expectations for total payment volumes ("TPV"). Specifically, digital TPV was impacted by increasingly competitive pricing in North America as enterprises focused on cost optimization and competitors were willing to offer lower pricing. Alibaba underperformed on weaker-than-expected Chinese demand for enterprise and cloud services, share losses to price-competitive peers, ongoing geopolitical challenges and China's underwhelming economic reopening. Rentokil underperformed on market share losses and signs of mismanagement.

During the period, SAP SE was added to the Fund as its S4Hana product is showing positive adoption trends that could last several years. In addition, the cloud backlog remains solid despite the macroeconomic backdrop. Shopify Inc. was purchased following the release of its third-quarter 2023 results, which showed gross merchandise value exceeding consensus expectations.

The Fund's existing position in NVIDIA was increased given evidence of increased adoption of processors for accelerated computing applications related to artificial intelligence ("AI") in data centres. RELX PLC was increased based on expected market share gains given the company's generative AI capabilities, particularly within legal markets.

The Fund's position in LVMH Moet Hennessy Louis Vuitton SE was exited on expectations of a slowdown in sales given the company's exposure to "aspirational customers," especially within its fashion and leather goods segment, which is about 40% of earnings. DBS Group Holdings Ltd. was sold in response to peaking net interest margins. In addition, the Fund's holdings in Adyen, Alibaba and Rentokil were exited in response to the underperformance noted above.

A position in Canadian National Railway Co. was decreased as persistently weak carloads reflected slowing import activity from China and nearshoring efforts focused on Mexico. Wolters Kluwer NV was decreased based on the limited progress made in commercializing proprietary datasets via AI tools and the potential for margin disappointment given human capital and data analytics investments.

The Fund's net asset value decreased to \$464.4 million at December 31, 2023, from \$470.1 million at December 31, 2022. This change was composed of net redemptions of \$82.3 million, cash distributions of \$26 and investment performance of \$76.6 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

The Fund may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions exceeds the portion of net income and net realized capital gains, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

There have been no recent developments that have affected, or are likely to materially affect the Fund.

Related Party Transactions

The Manager is a wholly owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 –

Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has four members, Stephen J. Griggs (Chair), Steven Donald, Heather A. T. Hunter and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are allocated among all of the funds managed by the Manager for which the IRC acts as the independent review committee in a manner that is considered by the Manager to be fair and reasonable. The main component of compensation is an annual retainer fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;

- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, did not rely on IRC standing instructions regarding related party transactions during the period.

Management Fees


The Manager is not entitled to a management fee payable by the Fund in respect of Series I units. The management fee is negotiable and paid by unitholders directly to the Manager.
