1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to Scotia Wealth Global Equity Pool.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 — Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with IFRS Accounting Standards.

# **Investment Objective and Strategies**

The Fund's investment objective is to achieve long-term returns through capital growth by investing primarily in stocks of large capitalization companies in North America, Europe, Australia and the Far East.

The Fund uses a fundamental growth-oriented investment style.

The Fund may invest up to 10% of its assets in securities of issuers in emerging markets and up to 15% of its assets in cash and cash equivalents.

The Fund can invest up to 100% of its assets in foreign securities.

#### Risk

The risks associated with investing in the Fund are as described in the simplified prospectus. There were no material changes to the Fund over its last completed financial year that affected the overall level of risk of the Fund.

# **Results of Operations**

For the year ended at December 31, 2023 (the "period"), the Pinnacle Series units of the Fund generated a total return of 21.7%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay

fees or incur expenses. Returns for other series of the Fund will be similar to Pinnacle Series with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the "Past Performance" section for the performance of the Fund's other series.

The Fund's broad-based benchmark, the MSCI World Index (C\$) returned 21.1% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund's performance relative to the general performance of the market.

After raising its key policy rate by 100 basis points ("bps") in the first half of 2023, the U.S. Federal Reserve Board paused in July and signalled the potential for as many as three policy rate decreases in 2024. Similarly, after raising its benchmark rate by 200 bps over the period, the European Central Bank stated that it would lower rates in the second quarter of 2024. China's central bank, facing a stalled economic rebound, lowered its key lending rates by 20 bps. The Bank of Japan maintained its negative interest rate policy despite rising inflation, citing subdued wage growth, lacklustre housing investment and flat government spending.

In March, the banking industry was negatively impacted by the sudden failure of U.S.-based Silicon Valley Bank. State regulators also closed New York-based specialty lender Signature Bank, causing shares of smaller regional banks across the U.S. to fall sharply as customers moved their deposits to larger institutions. Central banks in North America, Europe and Asia took coordinated action to improve U.S. dollar liquidity and ease global funding markets.

Investor interest in generative artificial intelligence ("AI") surged over the period, spurred by the release of ChatGPT in mid-March. This benefited the shares of several U.S. mega-capitalization companies with exposure to the technology, including NVIDIA Corp., Amazon.com Inc., Apple Inc., Alphabet Inc., Meta Platforms Inc., Tesla Inc. and Microsoft Corp.

The Fund tracked the broad-based benchmark as a result of stock selection in the U.S. and in the Communication Services and Health Care sectors.

Top individual contributors to performance included Meta Platforms, Schneider Electric SE and Alphabet. Meta Platforms benefited from increased efficiency, lower capital expenditures and increased share repurchases. Schneider Electric, a producer of industrial energy-management products, reported solid quarterly results and issued 2023 projections that exceeded expectations. Shares of Alphabet rose alongside a boom in spending on AI.

Stock selection in the Financials and Consumer Discretionary sectors detracted from the Fund's performance, as did an overweight allocation to Health Care. SVB Financial, the parent company of Silicon Valley Bank, was the largest detractor from performance after the company was placed into receivership. Other top detractors included First Republic Bank and John Deere. First Republic experienced a sharp drop in its share price amid the collapse of several U.S. regional banks. U.S. agricultural machinery manufacturer John Deere reported high levels of inventory, which some investors took as a sign of lower future sales.

Several new holdings were added to the Fund. AbbVie Inc. is a U.S. drugmaker known for Humira, a biologic used to treat a variety of autoimmune diseases. AbbVie has launched two new drugs that highlight its competitive advantage in discovery, development and commercial execution in autoimmune diseases. U.K.-based Haleon PLC is one of the world's largest consumer health companies in terms of revenue. Its competitive advantages include its extensive experience navigating regulatory frameworks, expansive portfolio of well-known consumer products and proven management team. Symrise AG is a German company operating in the flavours and fragrances industry, which has high barriers to entry. The company has a large position in pet food, which should provide a resilient source of growth.

Holdings in CME Group Inc., Kering SA and Thermo Fisher Scientific Inc. were among the positions increased. U.S. derivatives exchange CME Group traded at an attractive valuation. French luxury goods conglomerate Kering made progress toward its goal of diversifying away from Gucci. Share price weakness provided an opportunity to add to U.S. life science tool manufacturer Thermo Fisher Scientific at an attractive valuation.

Among the holdings sold were Align Technology Inc., Meituan and First Republic Bank. Align Technology is a global provider of clear aligners and dental scanning equipment whose stock appeared overvalued. The Fund's small position in Chinese food delivery platform Meituan was received as a result of its spin-off from Tencent Holdings Ltd. First Republic Bank was sold given investor pessimism around regional and commercial banks following Silicon Valley Bank's collapse.

Several positions were trimmed, including Synopsys Inc., DBS Group Holdings Ltd. and Adyen NV. The AI-induced tech rebounded boosted Synopsys's share price. Singapore-based bank DBS Group was trimmed to manage exposure to the Financials sector. Dutch payment processing services provider Adyen was trimmed to stay within the Fund's single-sector weight limit.

The Fund's net asset value increased to \$235.0 million at December 31, 2023, from \$212.6 million at December 31, 2022. This change was composed of investment performance of \$42.9 million, cash distributions of \$18,475 and net redemptions of \$20.5 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

### **Recent Developments**

There have been no recent developments that have affected, or are likely to materially affect the Fund.

# **Related Party Transactions**

The Manager is a wholly owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

#### Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pay the Manager a management fee for its services as described in the "Management Fee" section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly.

#### Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

## Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

#### Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107-

Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has four members, Stephen J. Griggs (Chair), Steven Donald, Heather A. T. Hunter and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are allocated among all of the funds managed by the Manager for which the IRC acts as the independent review committee in a manner that is considered by the Manager to be fair and reasonable. The main component of compensation is an annual retainer fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund:
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;

- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, did not rely on IRC standing instructions regarding related party transactions during the period.

# **Management Fees**

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.




### **Past Performance**



<sup>(4)</sup> The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.
