1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to Scotia Global Growth Fund.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 — Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with IFRS Accounting Standards.

Investment Objective and Strategies

The Fund's investment objective is long-term capital growth. It invests primarily in a broad range of equity securities of companies around the world.

The portfolio adviser uses fundamental analysis to identify investments that have the potential for above-average growth over the long term. This involves evaluating the financial condition and management of each company, as well as its industry and the economy. The Fund's assets are diversified by industry and company to help reduce risk.

The Fund can invest up to 100% of its assets in foreign securities.

Risk

The risks associated with investing in the Fund are as described in the simplified prospectus. There were no material changes to the Fund over its last completed financial year that affected the overall level of risk of the Fund.

Results of Operations

For the year ended at December 31, 2023 (the "period"), the Series A units of the Fund generated a total return of 15.0%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or

incur expenses. Returns for other series of the Fund will be similar to Series A with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the "Past Performance" section for the performance of the Fund's other series.

The Fund's broad-based benchmark, the MSCI ACWI (C\$) returned 19.6% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund's performance relative to the general performance of the market.

Global stock markets rebounded over the period, driven by a small group of the largest Information Technology companies. Breakthroughs in artificial intelligence earlier in the year restored a sense of optimism for growth equities. The failure of several regional U.S. banks affected markets in March. In addition, the widely anticipated global recession failed to materialize. Later in the period, inflationary pressures subsided and the U.S. Federal Reserve Board put its interest rate increases on hold. The market began to price in interest rate cuts in 2024 rather than further increases.

The Fund underperformed the broad-based benchmark as a result of stock selection in the Health Care sector and holdings in companies with substantial exposure to China.

Security selection within the Health Care sector was a top detractor from performance. Early-stage companies with deep scientific or technological expertise and leadership underperformed more established pharmaceutical companies and leaders in glucagon-like peptide 1 ("GLP-1", a weight loss drug). Holdings in companies with substantial revenue exposure to China also underperformed as a result of the country's weaker-than-expected recovery from pandemic-related lockdowns, its struggling real estate market and ongoing geopolitical issues.

Top individual detractors included Elevance Health Inc. and Moderna Inc. Large U.S. health insurance companies, such as Elevance Health, broadly declined in the middle of the period. In addition, because Elevance Health is an insurer with a large fixed income book on its balance sheet, its shares were negatively affected by concerns about the U.S. regional bank failures in March. Moderna became cash flow negative as a result of declining sales for its leading COVID-19 vaccine, coupled with heavy investment in its pipeline and manufacturing capabilities. Moderna expects a decline in overall revenue in 2024. An underweight position in outperforming stock NVIDIA Corp. and lack of exposure to Apple Inc., also detracted.

Holdings in construction materials companies contributed to performance as building material suppliers were able to maintain price increases for their products and supplies even as inflation fell. Demand in key end markets, such as infrastructure, remained high. Holdings in select companies that were out of favour in 2022 also contributed to performance. These companies rebounded as they adapted their businesses to the changing market environment.

Building materials company CRH PLC was a top individual contributor to performance. The company has been flexible to

rising costs, particularly the sharp increases in energy prices. CRH delivered solid earnings and sales growth, reflecting positive momentum and commercial progress across its key markets of North America and Europe. Another top contributor was Canadian e-commerce software and services company Shopify Inc. The company reported good results throughout the period, with growth being driven by an expanding global merchant base. Shares of building materials company Martin Marietta Materials Inc. appreciated by about 45%, largely driven by robust results. The company generated record revenues and increased gross profit by more than 38% year over year.

During the period, the Fund's exposure to the semiconductor industry was increased. The post-pandemic supply correction provided an opportunity to add holdings as demand from areas such as data centres and artificial intelligence continues to grow. New positions included Advanced Micro Devices Inc., ASM International NV, NVIDIA, Samsung Electronics Co. Ltd. and Texas Instruments Inc. Holdings were also added in cyclical businesses trading at attractive multiples and with underappreciated growth or durable competitive advantages. These included Advanced Drainage Systems Inc., Comfort Systems USA Inc., Floor & Décor Holdings Inc. and YETI Holdings Inc.

Several e-commerce, social media and software holdings that were out of favour with the market in 2022 were increased. Amazon.com Inc., Meta Platforms Inc., MercadoLibre Inc., CloudFlare Inc. and DoorDash Inc. have displayed good execution and cost discipline, which, combined with a reacceleration in growth, could drive share prices higher.

Several holdings were sold based on either a changing investment case or growth that was already priced into valuations. Axon Enterprise Inc., Booking Holdings Inc., Chegg Inc. and Twilio Inc. were among the holdings sold. The Fund's exposure to the insurance industry was reduced by trimming Prudential PLC and selling Ping An Insurance (Group) Co. of China Ltd. In addition, Tesla Inc., Li Auto Inc., Adobe Inc. and The Trade Desk Inc. were trimmed as their share prices rose.

The Fund's net asset value decreased to \$1,842.9 million at December 31, 2023, from \$1,971.3 million at December 31, 2022. This change was composed of net redemptions of \$432.6 million, cash distributions of \$413 and investment performance of \$304.2 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

There have been no recent developments that have affected, or are likely to materially affect the Fund.

Related Party Transactions

The Manager is a wholly owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pay the Manager a management fee for its services as described in the "Management Fee" section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund, other than Series F. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Administration Fee can be found in the Fund's most recent simplified prospectus.

Where applicable, the Series F of the Fund paid its proportionate share of the Fund's operating expenses that are common to all Series throughout the period.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses, Fixed Administration Fee, operating expenses or Fund Costs. These waivers or absorptions may be terminated at any time without notice.

Distribution Services

Certain registered dealers through which units of the Fund are distributed are related parties to the Fund and the Manager. The Manager may pay a trailing commission, which is negotiated with dealers, to dealers for their financial advisors in respect of the assets of their clients invested in securities of the Fund. The Manager, during the period, could also pay trailing commissions to

dealers for securities purchased or held through discount brokerage accounts.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 — Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has four members, Stephen J. Griggs (Chair), Steven Donald, Heather A. T. Hunter and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are allocated among all of the funds managed by the Manager for which the IRC acts as the independent review committee in a manner that is considered by the Manager to be fair and reasonable. The main component of compensation is an annual retainer fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;

- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, did not rely on IRC standing instructions regarding related party transactions during the period.

A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.




Past Performance


