The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with International Financial Reporting Standards ("IFRS").

Results of Operations

For the six-month period ended at June 30, 2023 (the "period"), the Series A Units of the Fund generated a total return of 4.2%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses. Returns for other series of the Fund will be similar to Series A Units of the Fund with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the "Past Performance" section for the performance of the Fund's other series.

The Fund's broad-based benchmarks, the S&P/TSX Composite Index and the FTSE Canada Universe Bond Index returned 5.7% and returned 2.5%, respectively, during the same period. In accordance with National Instrument 81-106, we have included a comparison to broad-based indices to help you understand the Fund's performance relative to the general performance of the market, but caution that the Fund's mandate may be significantly different from the index shown.

The Fund's blended benchmark, 45% S&P/TSX Composite Index, 45% FTSE Canada Universe Bond Index and 10% S&P 500

Index (C\$) returned 5.2% during the same period. We have included this comparison, which more closely reflects the market sectors and/or asset classes in which the Fund invests, to provide a more useful comparative to the performance of the Fund.

The Canadian equity market ended the six-month period in positive territory as the S&P/TSX Composite Index returned 5.7%. The major theme for the first half of 2023 was combating inflation by the central bank.

At the end of May 2023, we witnessed inflation dip from 6.3% in December 2022 to 3.4%. The slowdown was largely attributed to a decline in gasoline prices and an ease in supply chain bottlenecks. The result was broadly in line with the Bank of Canada's (BoC) baseline scenario that inflation will slow to the 3% mark by summer, raising doubts over the extent of rate hikes left in its tightening campaign. The BoC has raised interest rates only twice for the period closing at 4.75% – hitting a 15-year high in Canada. Though, it has not reached its target inflation rate of 2%, the central bank has hinted it is not done raising interest rates.

Against this backdrop, consumers got relief at the gas pumps as oil prices declined from \$80 U.S. dollars to around \$71 U.S. dollars per barrel. GDP growth rebounded to positive territory in the first quarter to 0.8% after remaining flat in the fourth quarter of 2022. The pause in rates alleviated Canada's housing market in making a strong recovery as home prices rose higher than what they were at this same time last year – it is the first time the housing market has seen a positive increase in prices on an annual basis.

Ten of the 11 GICS (Global Industry Classification Standard) sectors posted positive returns over the six-month period. The best performing sectors were Information Technology (47.5%), Consumer Discretionary (11.3%) and Industrials (+.7%). The worst performing sectors were Energy (-2.3%), Materials (0.6%) and Health Care (1.3%).

Over the period, the Canadian dollar strengthened against most major currencies including the Euro currency, Japanese yen and the U.S. dollar.

The U.S. equity market ended the six-month period in positive territory as the S&P 500 Index (C\$) returned 14.3%. The major theme was fighting inflation. The U.S. Federal Reserve (Fed) continued its policy on fighting inflation by raising the federal funds rate three times in the first half of 2023.

The good news is that inflation has been declining. For the period, inflation declined from 6.5% to 4.0% in May. One of the major contributors was the decline in oil prices from \$80 U.S. dollars to around \$71 U.S. dollars a barrel. However, the main barrier to inflation returning to the Fed's 2% target is the nearly 6% growth in wages – the labour market remains historically tight as the June unemployment rate was 3.6%. Fed Chair Jerome Powell could still hike one or two more times this year. He has repeatedly emphasized that letting inflation become entrenched would be a bigger mistake than overtightening and causing a recession.

From an economic perspective, the economy more broadly remains in good health with first quarter GDP numbers coming in around 2%, marking the third consecutive positive quarter of GDP growth. Corporate profits are expected to rebound and start growing again.

Six of the 11 GICS (Global Industry Classification Standard) sectors posted positive returns over the six-month period. The best performing sectors were Information Technology (39.6%), Communication Services (33.2%) and Consumer Discretionary (30.1%). The worst performing sectors were Utilities (-7.8%), Energy (-7.6%) and Health Care (-3.7%).

Over the period, the U.S. dollar weakened against the Canadian dollar and British pound, while strengthening against the Euro currency and Japanese yen.

The Canadian bond market, as represented by the FTSE Canada Universe Bond Index, finished up 2.5% for the six-month period ending June 30, 2023 as inflation remained stubborn across most global markets. The 10-year Government of Canada yield was volatile during the period, driven early on by contagion concerns over regional bank collapses in the U.S., though was relatively range-bound between 2.7% and 3.5% and finished the period basically flat at 3.3%. The Bank of Canada raised its policy rate by 25bps in January, paused its rate hiking schedule in March and April, before raising rates again in early June as inflation concerns refused to go away.

Within the U.S., the 10-year Treasury yield had been trending upwards early in the year before rallying sharply in March as markets reacted to the regional banking crisis in the U.S. They recovered slightly but then remained rangebound for the rest of the quarter finishing the period at 3.8%. The Federal Reserve weathered the financial crisis well and hiked rates three times by 25bps each in February, March and May, before opting to hold its key rate steady at 5% in June.

Investment grade and high yield credit spreads, as measured by ICE BofA Canadian and U.S. corporate indices OAS (Option-Adjusted Spread), rallied at the start of the year before widening materially in the midst of the bank crisis in March. As worries over contagion subsided, spreads drifted lower for the remainder of the year.

From a geographic perspective, Canada and the U.S. were positive contributors to performance, with Canada having the greater impact on performance. The sector exposure within the Fund is well-diversified, with Financials, Energy and Information Technology representing the top allocations. Overall, most sector allocations only saw small changes. Geographic and sector allocations are a by-product of the Portfolio Managers' bottom-up investment process.

At a sector level and on an absolute return basis, Information Technology, Financials and Consumer Discretionary were the largest contributors to performance with Utilities and Health Care holdings a detractor. Currency hedging was a slight positive contributor to returns. Individual securities that were top contributors included Microsoft Corporation, Power Corporation of Canada and CGI Incorporated. Top detractors included Northland Power Corporation, Toronto-Dominion Bank and Nutrien Limited.

The fixed income portion of the portfolio outperformed its benchmark over the period. The Fund outperformed its benchmark. Favourable tactical duration positioning offset the impact of

higher rates and drove relative performance. Curve positioning also added to relative performance as the Fund was underweight the front end of the yield curve, which inverted further during the period. These impacts were partially offset by marginally unfavourable sector positioning due to the Fund's bias to higher quality credit as lower rated issues outperformed.

The Fund's net asset value increased to \$2,315.0 million at June 30, 2023, from \$2,253.9 million at December 31, 2022. This change was composed of investment performance of \$95.5 million, cash distributions of \$43,191 and net redemptions of \$34.4 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

There have been no recent developments that have affected, or are likely to materially affect the Fund.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pay the Manager a management fee for its services as described in the "Management Fee" section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed

rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

Custodial Services

During the period, Scotiabank, as a custodian of the Fund, earned a fee for providing custody and related services. The custodian held investments of the Fund in safekeeping to ensure that they were used only for the benefit of the investors of the Fund. The custodian fee was paid by the Manager, in exchange for the Fixed Administration Fee received from the Fund.

Related Brokerage Commissions

From time to time, the Fund may enter into portfolio securities transactions with Scotia Capital Inc. or other related dealers in whom Scotiabank has a significant interest (a "Related Broker"). These Related Brokers may earn commission or spreads on such transactions, which are made on terms and conditions that are comparable to transactions made with non-related brokers.

During the period, the Fund paid \$11,080 in commissions to Related Brokers.

Distribution Services

Certain registered dealers through which units of the Fund are distributed are related parties to the Fund and the Manager. The Manager may pay a trailing commission, which is negotiated with dealers, to dealers for their financial advisors in respect of the assets of their clients invested in securities of the Fund. The Manager, during the period, could also pay trailing commissions to dealers for securities purchased or held through discount brokerage accounts.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the “IRC”) in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds (“NI 81-107”) with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager’s decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has five members, Stephen J. Griggs (Chair), Steven Donald, Simon Hitzig, Heather A. T. Hunter and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager’s website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are allocated among all of the funds managed by the Manager for which the IRC acts as the independent review committee in a manner that is considered by the Manager to be fair and reasonable. The main component of compensation is an annual retainer fee. Prior to November 1, 2021, each IRC member also received a fee for each committee meeting attended. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

Financial Highlights

The following tables show selected key financial information about each series of the Fund and are intended to help you understand the Fund’s financial performance for the periods indicated. The information on the following tables is based on prescribed regulations and as a result, is not expected to add across due to the increase (decrease) in net assets from operations being based on average units outstanding during the period and all other numbers being based on actual units outstanding at the relevant point in time. Footnotes for the tables are found at the end of the Financial Highlights section.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager’s written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, relied on IRC standing instructions regarding related party transactions during the period.

(2) The management expense ratio is based on the total expenses (including sales tax, and excluding commissions and other portfolio transaction costs) of each series of the Fund and a proportional share of underlying funds' expenses (mutual funds, ETFs and closed-end funds), where applicable, for the stated period and is expressed as an annualized percentage of daily average net asset value during the period.

(3) The trading expense ratio represents total commissions and other portfolio transaction costs, short borrowing costs and interest on leverage of the Fund and the underlying funds, where applicable, expressed as an annualized percentage of daily average net asset value of the Fund during the period.

(4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly.

The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.

The breakdown of services received in consideration of management fees for each series, as a percentage of the management fees, are as follows:

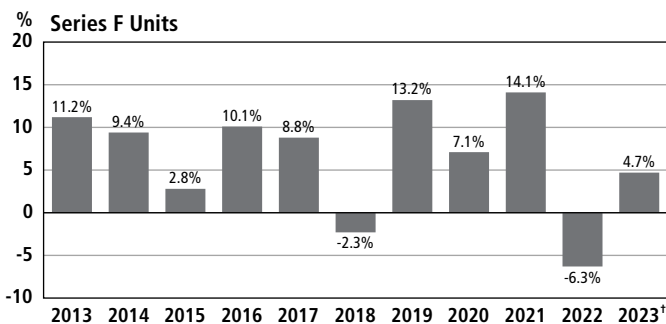
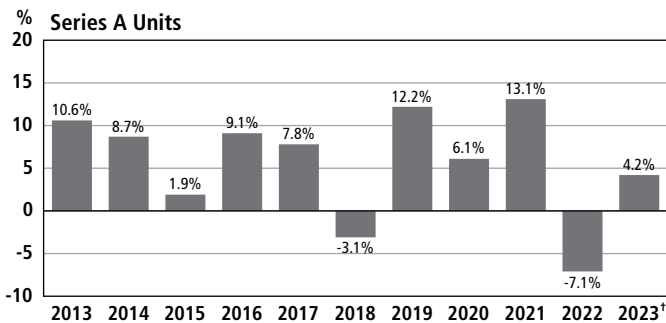
