Your monthly subscription will begin within two business days following receipt of your application and you get to enjoy the rest of the month for free! Subscriptions are based on calendar months.

**Non-Professional Agreement**

Only non-professional users are eligible to subscribe. To qualify as a non-professional you must meet the following criteria:

- You are an individual (not a firm, corporation, limited liability company, partnership, trust or other form of entity or association).
- You shall use the market information obtained through the Scotia OnLine service solely in connection with your individual personal investment activities and not in connection with any trade or business activities.
- You shall receive the market information only at one location (via Scotia OnLine) at a time and shall not furnish the information to any other person.
- You are not a securities broker, dealer, investment advisor, futures commission merchant, commodities introducing broker or commodity trading advisor, member of a securities exchange or association or futures contract market, or otherwise engaged in conducting professional activities involving the buying and selling of financial instruments such as stocks, bonds, options, futures contracts or other trading instruments.
- You are not an employee, owner, partner or associated person of any of the foregoing.
- You are not a person registered or qualified with a provincial securities commission, the Securities Exchange Commission, the Commodity Futures Trading Commission, the Financial Services Authority, any provincial, state or other governmental securities or derivatives agency, or any securities or derivatives exchange or association.
- You are not employed by a bank or an insurance company or an affiliate of either to perform functions related to securities or commodity futures investment or trading activity.
- You are not a consultant, independent contractor, software developer or provider or other that uses market information for any purpose for profit other than the trading of your personal account.
