## INTEREST RATES AND INTEREST CHARGES

<b>Annual percentage rate (APR) for Purchases</b>	<b>15.50%</b>
<b>APR for Cash Advances and Balance Transfers</b>	<b>19.99%</b>
<b>Penalty Rate and When it Applies</b>	<p>Up to <b>30%</b> APR. The Penalty Rate for which you qualify will depend on your creditworthiness, the seriousness and timing of your default, and other factors provided in your Scotiabank Cardholder Agreement.</p> <p>This APR may be applied to your Account if you:</p> <ul style="list-style-type: none"> <li>• fraudulently or materially misrepresent facts to us.</li> <li>• make a late payment.</li> <li>• make a payment to us that is not honored by your financial institution.</li> <li>• go over your credit limit.</li> <li>• fail to comply with the terms of your Scotiabank Cardholder Agreement.</li> <li>• become unwilling or unable to pay your debts to us or to others on time.</li> <li>• file for bankruptcy.</li> <li>• become incapacitated or in the event of your death.</li> <li>• a judgment is rendered against you.</li> <li>• breach of terms of workout or temporary hardship arrangement.</li> </ul> <p><b>How Long Will the Penalty APR apply?</b> If your APRs are increased for any of these reasons, the Penalty APR will apply until you make six consecutive minimum payments when due.</p>
<b>Paying Interest</b>	Your due date is at least 25 days after the close of each billing cycle. We will not charge you interest on purchases if you pay your entire balance by the due date every month. We will begin charging interest on Balance Transfers, Cash Advances and Scotiabank credit card checks on the date of the transaction.
