This is an offering of \$550,000,000 aggregate principal amount of our Floating Rate Senior Medium-Term Notes due 2028 (the “2028 Floating Rate Notes”), \$1,100,000,000 aggregate principal amount of our 4.404% Fixed-to-Floating Rate Senior Medium-Term Notes due 2028 (the “2028 Fixed-to-Floating Rate Notes”), and \$650,000,000 aggregate principal amount of our 4.740% Fixed-to-Floating Rate Senior Medium-Term Notes due 2032 (the “2032 Fixed-to-Floating Rate Notes” and, together with the 2028 Fixed-to-Floating Rate Notes, the “Fixed-to-Floating Rate Notes” and, together with the 2028 Floating Rate Notes, the “Notes”). We will pay interest on the 2028 Floating Rate Notes at a floating rate equal to Compounded SOFR (as defined in the Prospectus Supplement, as defined herein) plus 1.000%, payable quarterly in arrears on March 8, June 8, September 8 and December 8 of each year, commencing on December 8, 2024 (short first interest payment period) and continuing until September 8, 2028 or the applicable redemption date, subject to the Floating Rate Notes Payment Convention (as defined herein). We will pay interest on the 2028 Fixed-to-Floating Rate Notes (i) during the 2028 Fixed Rate Period (as defined herein), semi-annually in arrears on March 8 and September 8 of each year during the 2028 Fixed Rate Period, commencing on March 8, 2025 (short first interest payment period) and continuing until September 8, 2027 or the applicable redemption date, subject to the Fixed-to-Floating Rate Notes Payment Convention (as defined herein) and (ii) during the 2028 Floating Rate Period (as defined herein), at a floating rate equal to Compounded SOFR (as defined in the Prospectus Supplement, as defined herein) plus 1.000%, payable quarterly in arrears on December 8, 2027, March 8, 2028, June 8, 2028 and September 8, 2028 or the applicable redemption date, subject to the Fixed-to-Floating Rate Notes Payment Convention (as defined herein). We will pay interest on the 2032 Fixed-to-Floating Rate Notes (i) during the 2032 Fixed Rate Period (as defined herein), semi-annually in arrears on May 10 and November 10 of each year during the 2032 Fixed Rate Period, commencing on November 10, 2024 (short first interest payment period) and continuing until November 10, 2031 or the applicable redemption date, subject to the Fixed-to-Floating Rate Notes Payment Convention (as defined herein) and (ii) during the 2032 Floating Rate Period (as defined herein), at a floating rate equal to Compounded SOFR (as defined in the Prospectus Supplement, as defined herein) plus 1.440%, payable quarterly in arrears on February 10, 2032, May 10, 2032, August 10, 2032 and November 10, 2032 or the applicable redemption date, subject to the Fixed-to-Floating Rate Notes Payment Convention (as defined herein). The 2028 Floating Rate Notes will mature on September 8, 2028, the 2028 Fixed-to-Floating Rate Notes will mature on September 8, 2028, the 2032 Floating Rate Notes will mature on November 10, 2032. The Notes will be unsecured and unsubordinated obligations of The Bank of Nova Scotia (the “Bank”) and will constitute deposit liabilities of the Bank for purposes of the *Bank Act* (Canada). We will issue the Notes in minimum denominations of \$2,000 and integral multiples of \$1,000 in excess thereof.

The Notes will be bail-inable notes (as defined in the accompanying prospectus supplement dated December 29, 2021 (the “Prospectus Supplement”)) and subject to conversion in whole or in part – by means of a transaction or series of transactions and in one or more steps – into common shares of the Bank or any of its affiliates under subsection 39.2(2.3) of the Canada Deposit Insurance Corporation Act (the “CDIC Act”) and to variation or extinguishment in consequence, and subject to the application of the laws of the Province of Ontario and the federal laws of Canada applicable therein in respect of the operation of the CDIC Act with respect to the Notes.

We may redeem the Notes in whole or in part at any time and from time to time prior to maturity at the redemption prices described under the caption “Specific Terms of the Notes—Optional Redemption for the Notes” in this pricing supplement. There is no sinking fund for the Notes. All payments on the Notes are subject to our credit risk.

The Notes will not be listed on any securities exchange.

Investing in the Notes involves a number of risks. See “Risk Factors” on page P-5 of this pricing supplement, beginning on page S-2 of the Prospectus Supplement and beginning on page 11 of the accompanying prospectus dated December 29, 2021 (the “Prospectus”).

The Notes are unsecured and are not savings accounts or insured deposits of a bank. The Notes are not insured or guaranteed by the Canada Deposit Insurance Corporation, the U.S. Federal Deposit Insurance Corporation or any other governmental agency or instrumentality of Canada or the United States.

Neither the Securities and Exchange Commission nor any state securities commission has approved or disapproved of these securities or determined that this pricing supplement is truthful or complete. Any representation to the contrary is a criminal offense.

SPECIFIC TERMS OF THE NOTES

Please note that in this section entitled “Specific Terms of the Notes,” references to “holders” mean those who own Notes registered in their own names, on the books that we or the trustee maintain for this purpose, and not those who own beneficial interests in Notes registered in street name or in Notes issued in book-entry form through DTC or another depository. Owners of beneficial interests in the Notes should read the section entitled “Legal Ownership and Book-Entry Issuance” in the Prospectus.

The Notes are part of a series of senior debt securities entitled “Senior Medium-Term Notes, Series I,” that we may issue under our senior indenture, dated as of January 22, 2010, between the Bank and Computershare Trust Company of Canada, as Canadian trustee and Computershare Trust Company, N.A., as U.S. trustee, as supplemented by a first supplemental indenture, dated as of November 30, 2018 and by a second supplemental indenture, dated as of December 27, 2021, and as further amended, from time to time (the “indenture”). This pricing supplement summarizes financial and other terms that apply to the Notes. We describe terms that apply generally to all Series I Medium-Term Notes in “Description of the Notes We May Offer” in the Prospectus Supplement and in “Description of the Debt Securities We May Offer” in the Prospectus. The terms described in this pricing supplement should be read in conjunction with those described in the Prospectus and the Prospectus Supplement and, if the terms described here are inconsistent with those described there, the terms described here are controlling.

Please note that the information about the price to the public and the net proceeds to the Bank on the front cover of this pricing supplement relates only to the initial sale of the Notes. If you have purchased the Notes in a market-making transaction after the initial sale, information about the price and date of sale to you will be provided in a separate confirmation of sale.

In addition to the terms described on the front and inside cover of this pricing supplement, the following specific terms will apply to the Notes:

Defeasance

There shall be no defeasance, full or covenant, applicable to the Notes.

Payment at Maturity

At maturity you will receive an amount equal to the principal of your Notes plus any accrued and unpaid interest, subject to the Floating Rate Notes Payment Convention or the Fixed-to-Floating Rate Notes Payment Convention, as applicable.

Manner of Payment and Delivery

Any payment on the Notes at maturity will be made to accounts designated by you and approved by us, or at the office of the U.S. trustee in Greenwood Village, Colorado, but only when the Notes are surrendered to the U.S. trustee at that office. We also may make any payment in accordance with the applicable procedures of the depository.

Floating Rate Notes Interest

The interest rate on the 2028 Floating Rate Notes for each period will be equal to Compounded SOFR plus a spread of 100 basis points. Interest for the 2028 Floating Rate Notes will be payable quarterly in arrears on each March 8, June 8, September 8 and December 8, beginning on December 8, 2024 and ending on the Maturity Date or the redemption date, as the case may be, subject to the modified following, adjusted business day convention as described under the section “Terms of the Notes—\$550,000,000 Floating Rate Senior Medium-Term Notes due 2028—Floating Rate Notes Payment Convention”. The interest rate on the 2028 Floating Rate Notes will be calculated as described for SOFR Index notes in the section “Description of the Notes We May Offer—Interest Rates—SOFR Index Notes” in the Prospectus Supplement.

Fixed-to-Floating Rate Notes Interest

During the 2028 Fixed Rate Period, we will pay interest on the 2028 Fixed-to-Floating Rate Notes semi-annually in arrears on March 8 and September 8 of each year, commencing on March 8, 2025 (short first interest payment period) and continuing until September 8, 2027 or the redemption date, as the case may be, subject to the business day convention as described under the section “Terms of the Notes—\$1,100,000,000 4.404% Fixed-to-Floating Rate Senior Medium-Term Notes due 2028—Fixed-to-Floating Rate Notes Payment Convention”.

During the 2028 Floating Rate Period, the interest rate on the 2028 Fixed-to-Floating Rate Notes for each period will be equal to Compounded SOFR plus a spread of 100 basis points. Interest for the 2028 Fixed-to-Floating Rate Notes will be payable quarterly in arrears on December 8, 2027, March 8, 2028, June 8, 2028 and the Maturity Date or the redemption date, as the case may be, subject to the modified following, adjusted business day convention as described under the section “Terms of the Notes—\$1,100,000,000 4.404% Fixed-to-Floating Rate Senior Medium-Term Notes due 2028—Fixed-to-Floating Rate Notes Payment Convention”. During the 2028 Floating Rate Period, the interest rate on the 2028 Fixed-to-Floating Rate Notes will be calculated as described for SOFR Index notes in the section “Description of the Notes We May Offer—Interest Rates—SOFR Index Notes” in the Prospectus Supplement.

During the 2032 Fixed Rate Period, we will pay interest on the 2032 Fixed-to-Floating Rate Notes semi-annually in arrears on May 10 and November 10 of each year, commencing on November 10, 2024 (short first interest payment period) and continuing until November 10, 2031 or the redemption date, as the case may be, subject to the business day convention as described under the section “Terms of the Notes—\$650,000,000 4.740% Fixed-to-Floating Rate Senior Medium-Term Notes due 2032—Fixed-to-Floating Rate Notes Payment Convention”.

During the 2032 Floating Rate Period, the interest rate on the 2032 Fixed-to-Floating Rate Notes for each period will be equal to Compounded SOFR plus a spread of 144 basis points. Interest for the 2032 Fixed-to-Floating Rate Notes will be payable quarterly in arrears on February 10, 2032, May 10, 2032, August 10, 2032 and the Maturity Date or the redemption date, as the case may be, subject to the modified following, adjusted business day convention as described under the section “Terms of the Notes—\$650,000,000 4.740% Fixed-to-Floating Rate Senior Medium-Term Notes due 2032—Fixed-to-Floating Rate Notes Payment Convention”. During the 2032 Floating Rate Period, the interest rate on the 2032 Fixed-to-Floating Rate Notes will be calculated as described for SOFR Index notes in the section “Description of the Notes We May Offer—Interest Rates—SOFR Index Notes” in the Prospectus Supplement.

Calculation Agent

Computershare Trust Company, N.A. is currently serving as our calculation agent for the Floating Rate Notes and for the Fixed-to-Floating Rate Notes; however, we may change the calculation agent at any time without notice, and Computershare Trust Company, N.A. may resign as calculation agent at any time upon sixty (60) days’ written notice to the Bank.

Agreement with Respect to the Exercise of Canadian Bail-in Powers

By its acquisition of an interest in any Note, each holder or beneficial owner of that Note is deemed to (i) agree to be bound, in respect of that Note, by the CDIC Act, including the conversion of that Note, in whole or in part – by means of a transaction or series of transactions and in one or more steps – into common shares of the Bank or any of its affiliates under subsection 39.2(2.3) of the CDIC Act and the variation or extinguishment of that Note in consequence, and by the application of the laws of the Province of Ontario and the federal laws of Canada applicable therein in respect of the operation of the CDIC Act with respect to that Note; (ii) attorn and submit to the jurisdiction of the courts in the Province of Ontario with respect to the CDIC Act and those laws; (iii) have represented and warranted to the Bank that the Bank has not directly or indirectly provided financing to the holder for the express purpose of investing in the Note; and (iv) acknowledge and agree that the terms referred to in paragraphs (i) and (ii), above, are binding on that holder or beneficial owner despite any provisions in the indenture or that Note, any other law that governs that Note and any other agreement, arrangement or understanding between that holder or beneficial owner and the Bank with respect to that Note.

Holders and beneficial owners of any Note will have no further rights in respect of that Note to the extent that Note is converted in a bail-in conversion, other than those provided under the bail-in regime, and by its acquisition of an interest in any Note, each holder or beneficial owner of that Note is deemed to irrevocably consent to the converted portion of the principal amount of that Note and any accrued and unpaid interest thereon being deemed paid in full by the Bank by the issuance of common shares of the Bank (or, if applicable, any of its affiliates) upon the occurrence of a bail-in conversion, which bail-in conversion will occur without any further action on the part of that holder or beneficial owner or the trustee; provided that, for the avoidance of doubt, this consent will not limit or otherwise affect any rights that holders or beneficial owners may have under the bail-in regime.

- (1) (a) the sum of the present values of the remaining scheduled payments of principal and interest thereon discounted to the redemption date on a semi-annual basis (assuming a 360-day year consisting of twelve 30-day months) at the Treasury Rate plus 15 basis points less (b) interest accrued to the date of redemption, and
- (2) 100% of the principal amount of the 2028 Fixed-to-Floating Rate Notes to be redeemed,

plus, in either case, accrued and unpaid interest thereon to the redemption date.

“Treasury Rate” means, with respect to any redemption date, the yield determined by the Bank in accordance with the following two paragraphs.

The Treasury Rate shall be determined by the Bank after 4:15 p.m., New York City time (or after such time as yields on U.S. government securities are posted daily by the Board of Governors of the Federal Reserve System), on the third business day preceding the redemption date based upon the yield or yields for the most recent day that appear after such time on such day in the most recent statistical release published by the Board of Governors of the Federal Reserve System designated as “Selected Interest Rates (Daily) - H.15” (or any successor designation or publication) (“H.15”) under the caption “U.S. government securities—Treasury constant maturities—Nominal” (or any successor caption or heading). In determining the Treasury Rate, the Bank shall select, as applicable: (1) the yield for the Treasury constant maturity on H.15 exactly equal to the period from the redemption date to the Maturity Date of the 2028 Fixed-to-Floating Rate Notes (the “Remaining Life”); or (2) if there is no such Treasury constant maturity on H.15 exactly equal to the Remaining Life, the two yields – one yield corresponding to the Treasury constant maturity on H.15 immediately shorter than and one yield corresponding to the Treasury constant maturity on H.15 immediately longer than the Remaining Life – and shall interpolate to the Maturity Date of the 2028 Fixed-to-Floating Rate Notes on a straight-line basis (using the actual number of days) using such yields and rounding the result to three decimal places; or (3) if there is no such Treasury constant maturity on H.15 shorter than or longer than the Remaining Life, the yield for the single Treasury constant maturity on H.15 closest to the Remaining Life. For purposes of this paragraph, the applicable Treasury constant maturity or maturities on H.15 shall be deemed to have a maturity date equal to the relevant number of months or years, as applicable, of such Treasury constant maturity from the redemption date.

If on the third business day preceding the redemption date H.15 or any successor designation or publication is no longer published, the Bank shall calculate the Treasury Rate based on the rate per annum equal to the semi-annual equivalent yield to maturity at 11:00 a.m., New York City time, on the second business day preceding such redemption date of the United States Treasury security maturing on, or with a maturity that is closest to, the Maturity Date of the 2028 Fixed-to-Floating Rate Notes, as applicable. If there is no United States Treasury security maturing on the Maturity Date of the 2028 Fixed-to-Floating Rate Notes but there are two or more United States Treasury securities with a maturity date equally distant from the Maturity Date of the 2028 Fixed-to-Floating Rate Notes, one with a maturity date preceding the Maturity Date of the 2028 Fixed-to-Floating Rate Notes and one with a maturity date following the Maturity Date of the 2028 Fixed-to-Floating Rate Notes, the Bank shall select the United States Treasury security with a maturity date preceding the Maturity Date of the 2028 Fixed-to-Floating Rate Notes. If there are two or more United States Treasury securities maturing on the Maturity Date of the 2028 Fixed-to-Floating Rate Notes or two or more United States Treasury securities meeting the criteria of the preceding sentence, the Bank shall select from among these two or more United States Treasury securities the United States Treasury security that is trading closest to par based upon the average of the bid and asked prices for such United States Treasury securities at 11:00 a.m., New York City time. In determining the Treasury Rate in accordance with the terms of this paragraph, the semi-annual yield to maturity of the applicable United States Treasury security shall be based upon the average of the bid and asked prices (expressed as a percentage of principal amount) at 11:00 a.m., New York City time, of such United States Treasury security, and rounded to three decimal places.

The Bank's actions and determinations in determining the redemption price shall be conclusive and binding for all purposes, absent manifest error.

Optional Make Whole Redemption for 2032 Fixed-to-Floating Rate Notes

The Bank may redeem the 2032 Fixed-to-Floating Rate Notes at its option, in whole or in part, at any time and from time to time prior to November 10, 2031 (the date that is one year prior to the Maturity Date), at a redemption price (expressed as a percentage of principal amount and rounded to three decimal places) equal to the greater of:

- (1) (a) the sum of the present values of the remaining scheduled payments of principal and interest thereon discounted to the redemption date on a semi-annual basis (assuming a 360-day year consisting of twelve 30-day months) at the Treasury Rate plus 20 basis points less (b) interest accrued to the date of redemption, and
- (2) 100% of the principal amount of the 2032 Fixed-to-Floating Rate Notes to be redeemed,

plus, in either case, accrued and unpaid interest thereon to the redemption date.

"Treasury Rate" means, with respect to any redemption date, the yield determined by the Bank in accordance with the following two paragraphs.

The Treasury Rate shall be determined by the Bank after 4:15 p.m., New York City time (or after such time as yields on U.S. government securities are posted daily by the Board of Governors of the Federal Reserve System), on the third business day preceding the redemption date based upon the yield or yields for the most recent day that appear after such time on such day in the most recent statistical release published by the Board of Governors of the Federal Reserve System designated as "Selected Interest Rates (Daily) - H.15" (or any successor designation or publication) ("H.15") under the caption "U.S. government securities—Treasury constant maturities—Nominal" (or any successor caption or heading). In determining the Treasury Rate, the Bank shall select, as applicable: (1) the yield for the Treasury constant maturity on H.15 exactly equal to the period from the redemption date to the Maturity Date of the 2032 Fixed-to-Floating Rate Notes (the "Remaining Life"); or (2) if there is no such Treasury constant maturity on H.15 exactly equal to the Remaining Life, the two yields – one yield corresponding to the Treasury constant maturity on H.15 immediately shorter than and one yield corresponding to the Treasury constant maturity on H.15 immediately longer than the Remaining Life – and shall interpolate to the Maturity Date of the 2032 Fixed-to-Floating Rate Notes on a straight-line basis (using the actual number of days) using such yields and rounding the result to three decimal places; or (3) if there is no such Treasury constant maturity on H.15 shorter than or longer than the Remaining Life, the yield for the single Treasury constant maturity on H.15 closest to the Remaining Life. If on the third business day preceding the redemption date H.15 or any successor designation or publication is no longer published, the Bank shall calculate the Treasury Rate based on the rate per annum equal to the semi-annual equivalent yield to maturity at 11:00 a.m., New York City time, on the second business day preceding such redemption date of the United States Treasury security maturing on, or with a maturity that is closest to, the Maturity Date of the 2032 Fixed-to-Floating Rate Notes, as applicable. If there is no United States Treasury security maturing on the Maturity Date of the 2032 Fixed-to-Floating Rate Notes but there are two or more United States Treasury securities with a maturity date equally distant from the Maturity Date of the 2032 Fixed-to-Floating Rate Notes, one with a maturity date preceding the Maturity Date of the 2032 Fixed-to-Floating Rate Notes and one with a maturity date following the Maturity Date of the 2032 Fixed-to-Floating Rate Notes, the Bank shall select the United States Treasury security with a maturity date preceding the Maturity Date of the 2032 Fixed-to-Floating Rate Notes. If there are two or more United States Treasury securities maturing on the Maturity Date of the 2032 Fixed-to-Floating Rate Notes or two or more United States Treasury securities meeting the criteria of the preceding sentence, the Bank shall select from among these two or more United States Treasury securities the United States Treasury security that is trading closest to par based upon the average of the bid and asked prices for such United States Treasury securities at 11:00 a.m., New York City time. In determining the Treasury Rate in accordance with the terms of this paragraph, the semi-annual yield to maturity of the applicable United States Treasury security shall be based upon the average of the bid and asked prices (expressed as a percentage of principal amount) at 11:00 a.m., New York City time, of such United States Treasury security, and rounded to three decimal places.

The Bank's actions and determinations in determining the redemption price shall be conclusive and binding for all purposes, absent manifest error.

Optional Par Call Redemption

The Bank may redeem the 2028 Floating Rate Notes at its option (i) in whole, but not in part, on September 8, 2027 (the date that is one year prior to the Maturity Date) or (ii) in whole or in part, at any time and from time to time on or after August 9, 2028 (the date that is 30-days prior to the Maturity Date), in each case, at a redemption price equal to 100% of the principal amount of the 2028 Floating Rate Notes to be redeemed plus accrued and unpaid interest thereon to, but excluding, the redemption date.

The Bank may redeem the 2028 Fixed-to-Floating Rate Notes at its option (i) in whole, but not in part, on September 8, 2027 (the date that is one year prior to the Maturity Date) or (ii) in whole or in part, at any time and from time to time on or after August 9, 2028 (the date that is 30-days prior to the Maturity Date), in each case, at a redemption price equal to 100% of the principal amount of the 2028 Fixed-to-Floating Rate Notes to be redeemed plus accrued and unpaid interest thereon to, but excluding, the redemption date.

The Bank may redeem the 2032 Fixed-to-Floating Rate Notes at its option (i) in whole, but not in part, on November 10, 2031 (the date that is one year prior to the Maturity Date) or (ii) in whole or in part, at any time and from time to time on or after September 10, 2032 (the date that is two months prior to the Maturity Date), in each case, at a redemption price equal to 100% of the principal amount of the 2032 Fixed-to-Floating Rate Notes to be redeemed plus accrued and unpaid interest thereon to, but excluding, the redemption date.

Provisions Applicable to Optional Redemptions

Notice of any redemption will be mailed or electronically delivered (or otherwise transmitted in accordance with the depository's procedures) at least 5 days but not more than 30 days before the redemption date to each holder of Notes to be redeemed.

In the case of a partial redemption, selection of the Notes for redemption will be made pro rata, by lot or by such other method as the Trustee in its sole discretion deems appropriate and fair. No Notes of a principal amount of \$2,000 or less will be redeemed in part. If any note is to be redeemed in part only, the notice of redemption that relates to the note will state the portion of the principal amount of the note to be redeemed. A new note in a principal amount equal to the unredeemed portion of the note will be issued in the name of the holder of the note upon surrender for cancellation of the original note. For so long as the Notes are held by DTC (or another depository), the redemption of the Notes shall be done in accordance with the policies and procedures of the depository.

Unless the Bank defaults in payment of the redemption price, on and after the redemption date interest will cease to accrue on the Notes or portions thereof called for redemption.

The Bank may also redeem the Notes, in whole but not in part, at a redemption price equal to the principal amount of such Notes together with accrued and unpaid interest on such Notes to the date fixed for redemption under the circumstances described in “Description of the Notes We May Offer—Redemption at the Option of the Bank; No Sinking Fund—Tax Redemption” in the Prospectus Supplement.

The section “Canadian Taxation” in the Prospectus is amended by adding the following paragraph after the first paragraph on page 65 of the Prospectus:

“This summary is not applicable to a purchaser who is an entity in respect of which the Bank is a “specified entity” (as defined in the Tax Act) or is a “specified entity” in respect of any transferee resident (or deemed to be resident) in Canada to whom the purchaser disposes of the Notes.”

EMPLOYEE BENEFIT PLAN CONSIDERATIONS

Please see the discussion under the heading “Certain Considerations for ERISA and Other Employee Benefit Plans” (as amended below in this pricing supplement) in the Prospectus.

The section “Certain Considerations for ERISA and Other Employee Benefit Plans” in the Prospectus is amended by replacing in its entirety the fourth paragraph of this section on page 67 of the Prospectus:

“However, the applicability of each exemption depends on satisfaction of certain conditions, which may include the identity of the plan fiduciary making the decision to acquire or hold the securities on behalf of a Benefit Plan, and there can be no assurance that any of these exemptions or any other exemption will be available with respect to any particular transaction involving the securities. Even if the conditions specified in one or more of these exemptions are met, the scope of the relief provided by these exemptions might or might not cover all acts which might be construed as prohibited transactions.”

The section “Certain Considerations for ERISA and Other Employee Benefit Plans” in the Prospectus is amended by replacing in its entirety the fifth paragraph of this section beginning at the bottom of page 67 of the Prospectus:

“The securities may not be purchased or held by any Benefit Plan or anyone acting on behalf of a Benefit Plan, unless in each case the purchaser or holder is eligible for the exemptive relief under one or more of the PTCEs listed above, the service provider exemption or another applicable similar exemption. Any purchaser or holder (and, if applicable, its fiduciary) of the securities or any interest in the securities will be deemed to have represented by its acquisition and holding of the securities that either (i) it is not a Benefit Plan nor is it acquiring or holding such securities, or interest therein, with the assets of a Benefit Plan or (ii) the acquisition, holding or disposition of the securities does not and will not constitute a non-exempt prohibited transaction under Section 406 of ERISA or Section 4975 of the Code. In addition, any purchaser or holder (and, if applicable, its fiduciary) of the securities or any interest in the securities which is a non-ERISA arrangement subject to any similar law will be deemed to have represented by its acquisition and holding of the securities that its acquisition, holding and disposition does not and will not violate the provisions of any similar law.”

CLEARANCE AND SETTLEMENT

The Notes will settle through DTC, and its indirect participants Euroclear and Clearstream. For a description of DTC, Euroclear and Clearstream, see “Legal Ownership and Book-Entry Issuance” in the Prospectus.

SUPPLEMENTAL PLAN OF DISTRIBUTION (CONFLICTS OF INTEREST)

We have entered into a terms agreement, dated September 4, 2024, with the agents pursuant to the Distribution Agreement, dated December 29, 2021, among us and Scotia Capital (USA) Inc. for the purchase and sale of the Notes. We have agreed to sell to each of the agents, and each of the agents has agreed to purchase from us, the principal amount of the Notes shown opposite its name at the public offering price set forth above.

The agents may offer the Notes to certain dealers at such respective prices less a concession not in excess of 0.150% of the principal amount per 2028 Floating Rate Note, 0.150% of the principal amount per 2028 Fixed-to-Floating Rate Note, and 0.250% of the principal amount per 2032 Fixed-to-Floating Rate Note.

The agents may allow, and the dealers may reallow, a discount not in excess of 0.100% of the principal amount per 2028 Floating Rate Note, 0.100% of the principal amount per 2028 Fixed-to-Floating Rate Note, and 0.150% of the principal amount per 2032 Fixed-to-Floating Rate Note, to other dealers.

After the initial offering of the Notes, the concession and reallowance discounts on the Notes may change. The offering of the Notes by the agents is subject to receipt and acceptance and subject to the agents' right to reject any order in whole or in part.

We estimate that the total offering expenses for the Notes, excluding agents' fees, will be approximately \$100,000.

Subject to the terms and conditions of the terms agreement, the agents have agreed to purchase the Notes as principal, for their own account at a purchase price equal to the issue price specified on the front cover of this pricing supplement, less the agents' fees of 0.250% for the 2028 Floating Rate Notes, 0.250% for the 2028 Fixed-to-Floating Rate Notes and 0.400% for the 2032 Fixed-to-Floating Rate Notes. To the extent the agents resell Notes to a broker or dealer less a concession equal to the entire agents' fees, such broker or dealer may be deemed to be an "underwriter" of the Notes as such term is defined in the Securities Act of 1933, as amended. The agents have advised us that, if they are unable to sell all the Notes at the public offering price, the agents propose to offer the Notes from time to time for sale in negotiated transactions or otherwise, at prices to be determined at the time of sale.

In the future, the agents may repurchase and resell the Notes in market-making transactions. For more information about the plan of distribution, the Distribution Agreement (of which the terms agreement forms a part) and possible market-making activities, see "Supplemental Plan of Distribution" in the Prospectus Supplement. We expect that delivery of the Notes will be made against payment therefor on September 11, 2024, which is the fifth scheduled business day following the trade date. Under Rule 15c6-1 of the Securities Exchange Act of 1934, trades in the secondary market generally are required to settle no later than one business day after the trade date, unless the parties to any such trade expressly agree otherwise at the time of the trade. Accordingly, purchasers who wish to trade Notes on any date more than one business day prior to delivery of the Notes hereunder will be required, by virtue of the fact that the Notes will initially settle in five business days (T+5) to specify alternative settlement arrangements to prevent a failed settlement.

Certain of the Agents may not be U.S. registered broker-dealers and accordingly will not effect any sales within the United States except in compliance with applicable U.S. laws and regulations, including the rules of the Financial Industry Regulatory Authority (“FINRA”).

Conflicts of Interest

Because Scotia Capital (USA) Inc. is an affiliate of the Bank and is participating in the distribution of the Notes in this offering as an agent, Scotia Capital (USA) Inc. has a “conflict of interest” as defined in FINRA Rule 5121. Consequently, this offering is being conducted in compliance with FINRA Rule 5121. Scotia Capital (USA) Inc. is not permitted to sell Notes in this offering to accounts over which discretionary control is exercised without the prior specific written authority of the accountholder.

Some of the agents and their affiliates have engaged in, and may in the future engage in, investment banking and other commercial dealings in the ordinary course of business with us or our affiliates. They have received, or may in the future receive, customary fees and commissions for these transactions.

In addition, in the ordinary course of their business activities, the agents and their affiliates may make or hold a broad array of investments and actively trade debt and equity securities (or related derivative securities) and financial instruments (including bank loans) for their own account and for the accounts of their customers. Such investments and securities activities may involve securities and/or instruments of ours or our affiliates. Certain of the agents or their affiliates that have a lending relationship with us routinely hedge their credit exposure to us consistent with their customary risk management policies. Typically, such agents and their affiliates would hedge such exposure by entering into transactions which consist of either the purchase of credit default swaps or the creation of short positions in our securities, including potentially the Notes offered hereby. The agents have been represented by Mayer Brown LLP, New York, New York as to matters of the federal law of the United States and New York law.
